The attention of all the District Educational Officers & Ex-Officio District Project Officers of Samagra Shiksha in the State is invited to the references read above.

The General Merit List for all categories of posts for the online tests held from 24.07.2023 to 26.07.2023 for filling up of Teaching Vacancies in KGBVs and URSs on contract basis during the academic year 2023-24 are sent herewith.

In this context, all the DEOs & EO-DPOs, SS in the State are requested to take up process of positioning the services of personnel in the vacant posts purely on contract basis with respect to existing vacancies duly following the under mentioned schedule.

10	Conduct of counseling for engaging in vacancies and issue of orders for engaging the services of candidates on contract basis by directing the candidates to join the duty in the respective vacant post by 5.00 PM on 13.08.2023	13.08.2023

Further, the DEOs & EO-DPOs, SS in the State are requested to ensure the following strictly to take up the selection process.

1. To follow the guidelines issued in the Notification dated 16.06.2023 in the reference 1st read above to engage the personnel purely on contract basis strictly.
2. To follow the Schedule for selection process strictly.
3. As per Clause (12) (iv) & (12) (vii) (g) of Notification, selection of candidates will be based on merit & rule of reservation and unit of recruitment is **New District**. Therefore, fresh roaster (starting from cycle 1) has to be drawn for each category of post **new District wise**.
4. Verification Teams consisting of minimum 3 personnel (at least one of them should be Gazetted) who are well versed with rules & regulations in vogue w.r.t. recruitment process may be constituted for verification of Certificates. Written orders are to be issued to the teams to take up verification process as per terms & conditions of Notification.
5. As per Clause 11(iv) of Notification, the claim of the candidates with regard to the date of birth, educational / professional qualifications, community, local candidature, claiming of TET weightage for the respective posts, claiming of weightage marks (Clause 15 (iii) & 15 (iv) of Notification) and other claims if any submitted in the online application are only provisional and these are subject to verification at the time of certificates verification of candidates.
6. District Level Committee with the following officers has to be constituted at District Level for finalization of entire selection process as per existing vacancies duly following the terms & conditions and guidelines of Notification as per reference 2nd cited.
 - i) District Collector - Chairman
 - ii) Addl. Collector - Vice Chairman
 - iii) District Educational Officer - Member Secretary
 - iv) One District Officer as nominated - Member
by the Dist. Collector

Therefore, the DEOs & EO-DPOs, SS in the State are requested to take immediate action as above without any deviation and upon joining by the candidates within the due date (**i.e., by 5.00 PM on 13.08.2023**), they have to enter **contractual agreement** with the candidates to work on contract basis from the **date of their joining till 24.04.2024** duly following the existing procedure being followed in respect of KGBVs and URSSs. Further, they are requested to furnish compliance report in the matter by **14.08.2023**.

Any deviation in the matter, the concerned DEO & EO-DPO, SS will be held responsible and the matter will be viewed seriously.

They are further informed that as per Clause (2) of Notification, the merit list is valid up to (2) years from the date of initial engagement to fill the vacancies that arise from time to time in the respective Districts.
