The attention of all the Erstwhile District Educational Officers in the State are invited to the references 13<sup>th</sup> read above, and they are informed that the Secretary, Telangana State Public Service Commission, Hyderabad has furnished Unit list of Provisionally selected Candidates for the category of **Secondary Grade Teacher - English Medium** and same were communicated by this office to all the Erstwhile District Educational Officers in the State for issuing appointment orders to the selected candidates in TRT-2017.

Further, they are informed that the Commission has instructed that **“appointment orders may be sent to the candidates ( except for Agency posts) as per the unit list made available with department”** and before issuing appointment orders it may be ensured that, all the original certificates of the candidates are verified before admitting the candidates into service. In case of non-production of any requisite certificate in original or any discrepancy is noticed the unit, Officer may take action as per the Rules in force before issuing appointment orders. If any candidates fails to report to duty, his/her name may be deleted from the approved list, and a notice, may be sent to the candidates that his/her name has been deleted from the approved list to meet the legal requirements. A consolidated order may be issued in respect of all such deleted candidates and send a copy to the Commission to re-notify these vacancies after the expiry of the stipulated time to report for duty. The whole exercise should be completed as per the schedule.

Therefore, the schedule is herewith communicated to all the District Educational Officers in the State for issuing appointment orders to the post of **Secondary Grade Teacher- English Medium (except for Agency posts)** duly taking over the Selection lists from the District Collectors and the appointment orders may be issued to the candidates (except for Agency posts) as the unit list made available with you and also **strictly following** G.O.Ms.No.10 SE Dept, School Education (General) Dept dated.06-07-2019 and also **the instructions issued by the TSPSC in issuing appointment & posting orders** to the selected candidates as per the eligibility criteria stipulated in the G.O.Ms.No.25 SE dept, dated.10-10-2017.
